Dear Fellow Community League Ambassadors:

#### Re: Request to attend your next board meeting and administer a research survey to executive.

My name is Nora Begoray. You may recognize this name as I am currently on staff with the Edmonton Federation of Community Leagues. (EFCL)

Before I became a staff member of the EFCL I was a long-time member of my community league of Parkallen. I held several roles with that executive including Social and Program Director, Chair of the Park Redevelopment Committee, Vice-president and President.

### **Proposed 2016-2018 Operating Budget Adjustment**

The City released its proposed 2016-2018 Supplemental Operating Budget Adjustment that maintains all City programs and services for \$6.61 per day in municipal property taxes for the typical household. The 2017 budget adjustment is <u>online</u>, giving Edmontonians time to review the details before council begins deliberations in December.

The proposed property tax of 3.1 per cent remains at the level City Council approved in Spring 2016, a decrease from the 3.4 per cent increase that was originally forecast when Council announced the three-year operating budget in 2015.

Edmontonians are encouraged to learn about the budget by visiting <a href="YEGcityBudget.ca">YEGcityBudget.ca</a>. The 2017 Supplemental Operating Budget Adjustment was presented at the November 29 Council meeting. Interested residents and organizations are invited to provide input to Council at a December 8 public hearing. ### The MGA and the City Charter

Bev and I met with the Executive Director, Major Legislative Projects, Municipal Affairs, Alexander Nnamonu and the Executive Director of the Community Engagement Branch, Culture and Tourism, Carol Moerth to discuss the proposed changes to the MGA and were reassured that there would not be a reclassification of Municipal Reserve land. This is still something the EFCL will need to watch as the City has used MR land before. We also asked some preliminary questions about the upcoming City Charters and have been referred to another person. Meanwhile, we have held our first meeting with the City Charter Committee and have made some progress getting through the information together.

### **Pixel Blue Sponsorship**

Nora and I met with Pixel Blue and have selected our top logos. A sample is included in the package. A story board has also gone to the Animation Course Instructor and a short video to promote the Plaza Project will be developed.

### **Live Active Summit**

Ever Active Schools, the Edmonton Sport Council and the Be Fit For Life Centre are excited to be hosting the Live Active Summit in Edmonton, April 6-8, 2017 at Commonwealth. This event is an educational opportunity and also a catalyst for physical literacy, sport and active living in Alberta. The event will also be working alongside the City of Edmonton and hopefully the many organizations on the Steering Committee. The EFCL is part of the Steering Committee.

**Description of the Summit:** The Summit will be a catalyst to educate, engage and bring to life active living, active recreation and sport in a school and community setting. It will involve collaborative work around physical literacy and share successful practices from across the province. The goal of this summit is to highlight and experience best practices that have clear tangible outcomes.

The Summit will be a platform to highlight the wellbeing benefits of living active in cities, schools, and communities. It will bring together the sectors of education, health, active transportation, sport, and recreation and anyone interested in meaningful participation in development of a healthy active population. The Summit will educate, inform and inspire us to move more. There is a plan to include Saturday workshops this year so Program Directors from community leagues can attend.

## Fundraising for 100<sup>th</sup> Anniversary

Met with Bill Moore-Kilgannon who offered some suggestions for funding. We have held two Corporate Cabinet meetings which have gone well. We have created a prospect list and will begin to steward potential donors.

### **Community Development Corporation**

The EFCL presented to Council on its' support for the CDC along with Right At Home Housing, the Bissell Centre and a developer. The Executive Committee recommended that the CDC move forward and be presented to Council.

### **Rink Race**

Lorelei Beaumaris won  $1^{st}$  place for the Board Rink Race. Crestwood won  $2^{nd}$  place and McCauley came in  $3^{rd}$ . This year we expanded to include a separate category for Snow Bank Rinks and so far we have a  $1^{st}$  place winner – Grandview Heights.

### **Leder School of Business Social Housing Project**

As the work of the Council Initiative on Public Engagement continues, each of the five Working Groups have been focused on achieving the goals and objectives of their actions plans. And their work will help form the basis of a strategy that will go to City Council for policy approval in spring 2017.

This is outlined in our <u>Phase 2 Interim Update report</u> on the Council Initiative's progress and achievements from the beginning of Phase 2 in fall 2015 up until now, with an outline of what's to come on the horizon in the spring.

On behalf of the Federation, Bev Zubot and Elaine Solez are part of the Community Leaders Working Group. At the November 19 All Working Group Assembly, this group presented the following goals and actions:

Goal 1: City of Edmonton employees have tools and resources for developing relationships and building capacity in community leaders.

### Actions:

- Community Inventory and Mapping Tool to identify organizations and individuals who could be engaged
- Community Engagement Facilitators who have ongoing relationships with community leaders (including leagues) and can link city project staff to community leaders
- The City will develop an interconnected map of community-facing roles within the organization

Goal 2 City of Edmonton employees support and understand how to capitalize on the strengths of community leaders

- Integrate community engagement facilitators into public engagement planning process
- Civic education strategy
- Integrate inclusive language and methodologies into public engagement communication and tools and techniques

Goal 3 Opportunities and resources to enhance the roles of community leaders

- Promote available city resources for public engagement
- Identify and create community leadership competency development opportunities for public engagement (EFCL could create learning opportunities for leagues if given some resources to do so.)

Another recommendation of the Community Leaders Working Group:

• Form a Guiding Coalition (of city and community people) to monitor and advise the work of the Engagement Branch which will implement the new Public Engagement Strategy
