

# Contest Rules & Regulations

## Prize value: Each gift card is valued at \$250.00

Contest Sponsor: Servus Credit Union

Contest Name: Enter to Win One of two \$250 gift cards to Snow Valley and Rainbow Valley

The Contest is governed by the rules set forth below. By entering the contest, you agree to abide by these rules and decision of the Contest Sponsor. You also agree to comply with all applicable laws.

## Contest Period

Contest Start Date: September 21, 2024, at 8am Mountain Standard Time

Contest End Date: September 21, 2024, at 11pm Mountain Standard Time

Entries must be received by the Contest Sponsor within the Contest Period to be eligible to win.

## Entrant Eligibility

- The Contest is open to legal residents of Alberta who are eighteen (18) years of age or older as of the date of their entry and who are not employees, retirees or representatives of the Contest Sponsor or their respective affiliates, subsidiaries, related companies, agents, associates, dealers, representatives, advertising or promotional agencies or members of the immediate families of those employees and retirees or any persons with whom they are domiciled.
- For purposes of the Contest, "members of the immediate families" is defined as sibling, spouse, mother, father, grandparents, stepmother/father, brother, sister, son and/or daughter.
- The Contest Sponsor shall have the right at any time to require proof of identity and/or eligibility to participate in The Contest. Failure to provide such proof may result in disqualification.
- All personal and other information requested by and supplied to the Contest Sponsor for the purpose of The Contest must be truthful, complete, accurate and in no way misleading.

# Contest Rules & Regulations

## How to Enter

**Scan the QR Code – all eligible entrants who scan the QR code and complete the entry form will be entered into the contest.**

Alternate Means – No purchase entry. To enter the contest, handprint the contest name, your first name, last name, address, city, province, postal code, day and evening phone number, the date of your request for a no purchase entry and mail in an envelope to: Servus Credit Union, Marketing Dept. One entry will be made into the contest providing that the envelope is received bearing sufficient postage prior to The Contest closing date. The Contest Sponsor will not be responsible for any lost, delayed, misdirected, illegible, incomplete, damaged or undeliverable entries, or any delay or failure to transmit, process, receive or consider entries. There is maximum of one (1) entry person for the alternate means of The Contest entry method. The Contest is void where prohibited or restricted by law. The Contest is subject to all applicable, federal, provincial and local laws and regulations.

## Prize(s)

There will be a total of two (2) draws. Each draw will consist of (1) \$250 gift card to be used at Snow Valley and Rainbow Valley

**The Contest draw will be made on: Monday, September 23, 2024, at 12pm Mountain Standard Time.**

*Once a winner is confirmed the prize will be sent to the nearest Servus Credit Union Branch where the winner can pick up their prize.*

A Servus Credit Union representative will randomly select winner(s) from all eligible entries received during the Contest Period. The odds of being selected as a winner are dependent on the total number of eligible entries received. The winner will be verified and then contacted by a Servus Credit Union representative by telephone. In the event that the winner cannot be contacted within forty-eight (48) hours, despite customary diligent efforts, they will be disqualified, and another winner chosen. The initial selected disqualified potential winner(s) will have no recourse toward the Contest Sponsor.

- If a potential winner cannot accept the Prize as awarded for any reason, his or her entry will be forfeited, and another eligible entrant may be selected. ·
- Prize must be accepted as awarded and cannot be transferred to another person, substituted for another prize or exchanged in whole or in part for cash. The Contest Sponsor reserves the right to substitute a prize of at least equal or greater value in the event of unavailability, for whatever reason, of the advertised prize.

The Contest Sponsor shall have no liability for any loss or damage resulting directly or indirectly from your participation in The Contest.

The Contest Sponsor is not responsible for: (1) incorrect or inaccurate transcription of entry information or late, lost, incomplete, misdirected entries, or entries received through impermissible or illegitimate channels; (2) technical failures of any kind, including without limitation the malfunctioning of any telephone, computer, network, hardware or software; (3) the unavailability or inaccessibility of any service; (4) unauthorized human intervention in any part of the entry process or the Contest; (5) electronic or human error which may occur in the administration of the Contest or the processing of entries; or (6) any injury or damage to

The Contest Sponsor will not be liable to you for any indirect, special, consequential, or punitive damages in connection with the Contest or these Rules & Regulations.

### Privacy/Use of Personal Information

By participating in The Contest an entrant: (a) grants to the Contest Sponsor the right to use his/her name, mailing address, telephone number, and e-mail address (“Personal Information”) for the purpose of administering The Contest, including but not limited to contacting the Winner; and (b) acknowledges that the Contest Sponsor may disclose the entrant's Personal Information to third-party agents and service providers of any of the Contest Sponsor in connection with any of the activities listed in (a) above.

The Competition Sponsor will destroy all records containing personal information and/or render the personal information non-identifying so that it can no longer be used to identify any participant in The Contest, 24 months after The Contest close date.

### Use At Entrant's Option:

If for any reason the Contest Sponsor cannot run The Contest as planned, (including as a result of: no entries received, bugs, tampering, unauthorized intervention, fraud, technical failures, infection by computer virus or any other cause that corrupts, impairs or affects the administration, security, fairness, integrity, or proper conduct of the Contest) the Contest Sponsor reserves the right to cancel, modify, extend or suspend The Contest. In that event, the Contest Sponsor may award a prize at random from among the eligible entries received up to the time of the impairment or cancel The Contest.

### Law

These Rules & Regulations constitute the complete Rules and Regulations associated with The Contest. The Contest is subject to applicable federal, provincial and municipal laws and regulations. These Contest Rules & Regulations are subject to change without notice in order to

comply with any applicable federal, provincial and municipal laws or the policy of any other entity having jurisdiction over the Contest Sponsor. All issues and questions concerning the construction, validity, interpretation and enforceability of the Contest Rules & Regulations or the rights and obligations as between the entrant and the Contest Sponsor in connection with the Contest shall be governed by and construed in accordance with the laws of the province of Alberta.

## Disputes

All disputes, claims and causes of action arising out of or connected with the Contests, prizes or these Rules & Regulations will be resolved individually, without resort to any form of class action, and exclusively by the appropriate court of the Province of Alberta, Canada, in Edmonton, Alberta.

## Language Discrepancy

In the event of any discrepancy or inconsistency between the terms and conditions of the Contest Rules & Regulations and disclosures or other statements contained in any contest-related materials, including but not limited to the Contest entry forms, or point of sale, print or online advertising, the terms and conditions of these Contest Rules & Regulations shall prevail, govern and control.

## General Rules
